

SOFTWARE LICENSE AGREEMENT

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE DOWNLOADING, INSTALLING OR USING THE SOFTWARE OR ANY ACCOMPANYING DOCUMENTATION (COLLECTIVELY, THE “SOFTWARE”).

THE TERMS AND CONDITIONS OF THIS SOFTWARE LICENSE AGREEMENT (“AGREEMENT”) GOVERNS USE OF THE SOFTWARE UNLESS THE PARTIES HERETO HAVE EXECUTED A SEPARATE AGREEMENT.

GEFEN, LLC is willing to license the Software to you only upon the condition that you accept all the terms contained in this Agreement. By clicking on the “I accept” button below or by downloading, installing or using the Software, you, on behalf of yourself and your employer (collectively “Licensee”) have indicated that Licensee understands this Agreement and accepts all of its terms. If Licensee does not accept all the terms of this Agreement, then GEFEN, LLC is unwilling to license the Software to Licensee.

- 1. Grant of License.** Subject to Licensee’s compliance with the terms and conditions of this Agreement, GEFEN, LLC grants Licensee a non-exclusive and non-transferable license to install and use the executable form of the Software on a single computer, solely for Licensee’s use with the Gefen product that is compatible with this Software. Licensee may make a single copy of the Software for backup purposes, provided that Licensee reproduce on it all copyright and other proprietary notices that are on the original copy of the Software. GEFEN, LLC reserves all rights in the Software not expressly granted to Licensee in this Agreement.
- 2. Restrictions.** Except as expressly specified in this Agreement, Licensee may not: (a) copy or modify the Software; (b) transfer, sublicense, lease, lend, rent or otherwise distribute the Software to any third party; or (c) make the functionality of the Software available to multiple users through any hosting, application services provider, service bureau or any other type of services. Licensee acknowledge and agree that portions of the Software, including, without limitation, the source code and the specific design and structure of individual modules or programs, constitute or contain trade secrets of GEFEN, LLC and its licensors. Accordingly, Licensee agrees not to disassemble, decompile or otherwise reverse engineer the Software, in whole or in part, or permit or authorize a third party to do so, except to the extent such activities are expressly permitted by law notwithstanding this prohibition.
- 3. Ownership.** The Software is licensed, not sold. GEFEN, LLC retains ownership of the Software, including all intellectual property rights therein. The Software is protected by United States patent, copyright, and trade secret law and international treaties. Licensee will not delete or in any manner alter the copyright, trademark, and other proprietary rights notices or markings appearing on the Software as delivered to Licensee.
- 4. Term.** This Agreement remains effective until terminated. GEFEN, LLC may terminate this Agreement at any time, with or without cause, upon providing Licensee with notice of such termination. Licensee may terminate it at any time by destroying all copies of the Software in Licensee’s possession or control. This Agreement will automatically terminate without notice if Licensee breaches any term of this Agreement. Upon termination, all licenses hereunder shall immediately terminate and Licensee must promptly destroy all copies of the Software in their possession or control and certify in writing to GEFEN, LLC of such destruction writing within thirty (30) days.
- 5. DISCLAIMER.** THE SOFTWARE IS PROVIDED “AS IS” AND WITHOUT WARRANTY OF ANY KIND. GEFEN, LLC AND ITS SUPPLIERS EXPRESSLY DISCLAIM ALL WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NONINFRINGEMENT, AND ANY WARRANTIES AND CONDITIONS ARISING OUT OF COURSE OF DEALING OR USAGE OF TRADE. NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED FROM GEFEN, LLC OR ELSEWHERE WILL CREATE ANY WARRANTY OR CONDITION NOT EXPRESSLY STATED IN THIS AGREEMENT.
- 6. Limitation of Liability.** GEFEN, LLC AND ITS SUPPLIERS’ TOTAL LIABILITY TO LICENSEE FROM ALL CAUSES OF ACTION AND UNDER ALL THEORIES OF LIABILITY WILL BE LIMITED TO AND WILL NOT EXCEED THE AMOUNTS PAID TO GEFEN, LLC BY LICENSEE FOR THE SOFTWARE. IN NO EVENT WILL GEFEN, LLC BE LIABLE TO LICENSEE FOR ANY SPECIAL, INCIDENTAL, EXEMPLARY, PUNITIVE OR CONSEQUENTIAL DAMAGES (INCLUDING LOSS OF USE, DATA, BUSINESS OR PROFITS) OR FOR THE COST OF PROCURING SUBSTITUTE PRODUCTS ARISING OUT OF OR IN CONNECTION WITH THIS

AGREEMENT OR THE USE OR PERFORMANCE OF THE SOFTWARE, WHETHER SUCH LIABILITY ARISES FROM ANY CLAIM BASED UPON CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE, AND WHETHER OR NOT GEFEN, LLC HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH LOSS OR DAMAGE. THE FOREGOING LIMITATIONS WILL SURVIVE AND APPLY EVEN IF ANY LIMITED REMEDY SPECIFIED IN THIS AGREEMENT IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.

7. Government Users. Any use, duplication, or disclosure of the Software by the U.S. government is subject to restrictions as set forth in this Agreement and as provided in DFARS 227.7202-1(a) and 227.7202-3(a) (1995), DFARS 252.227-7013(c)(1)(ii) (OCT 1988), FAR 12.212(a) (1995), FAR 52.227-19, or FAR 52.227-14 (ALT III), as applicable.

8. Export Law. Licensee agrees to comply fully with all U.S. export laws and regulations to ensure that neither the Software nor any technical data related thereto nor any direct product thereof are exported or re-exported directly or indirectly in violation of, or used for any purposes prohibited by, such laws and regulations.

9. General. This Agreement will be governed by and construed in accordance with the laws of the State of California, without regard to or application of conflicts of law rules or principles. The United Nations Convention on Contracts for the International Sale of Goods will not apply. Licensee may not assign or transfer this Agreement or any rights granted hereunder, by operation of law or otherwise, without GEFEN, LLC's prior written consent, and any attempt by Licensee to do so, without such consent, will be void and of no effect. Except as expressly set forth in this Agreement, the exercise by either party of any of its remedies under this Agreement will be without prejudice to its other remedies under this Agreement or otherwise. All notices or approvals required or permitted under this Agreement will be in writing and delivered by confirmed facsimile transmission, by overnight delivery service, or by certified mail, and in each instance will be deemed given upon receipt. All notices or approvals will be sent to the addresses set forth in the applicable ordering document or invoice or to such other address as may be specified by either party to the other in accordance with this section. The failure by either party to enforce any provision of this Agreement will not constitute a waiver of future enforcement of that or any other provision. Any waiver, modification or amendment of any provision of this Agreement will be effective only if in writing and signed by authorized representatives of both parties. If any provision of this Agreement is held to be unenforceable or invalid, that provision will be enforced to the maximum extent possible and the other provisions will remain in full force and effect. This Agreement is the complete and exclusive understanding and agreement between the parties regarding its subject matter, and supersedes all proposals, understandings or communications between the parties, oral or written, regarding its subject matter, unless Licensee and GEFEN, LLC have executed a separate agreement. Any terms or conditions contained in your purchase order or other ordering document that are inconsistent with or in addition to the terms and conditions of this Agreement are hereby rejected by GEFEN, LLC and will be deemed null and of no effect.
